# Over £2,500 raised for local good causes

Wace Morgan has donated a grand total of £2,500 to charities and worthwhile organisations in Shropshire and Mid-Wales.

In addition we contributed to a new defibrillator to be installed in Market Street, Newtown, by the Community Heartbeat Trust.

There will be more fund raising activities by staff during our annual office 'Charity Week' from 10th December, including a Bake Off for Refuge in Church Stretton and Christmas Jumper Day in aid of Save The Children.

We also announced our three Christmas Charities, who will each receive a donation of £500 as part of our commitment to supporting local causes. These are Lingen Davies, SSAFA and Shropshire Rural Support.


